Synopsis: To claim statistical accomplishment for subject interview and document information obtained by [Redacted]

Administrative: The individual named in this EC was participating in activities which are protected by the First Amendment to the United States Constitution. the individuals inclusion is not intended to directly or indirectly associate the protected activity with criminality or to infer that such protected activity itself violates federal law or presents a threat to national security.

However, based on known intelligence and/or specific, historical observation, it is possible the protected activity could invite a violent or otherwise incendiary reaction towards the subject individual or others in retaliation or to stop the protected activity from occurring in the first instance. Accordingly, information concerning the protected activity is included in this alert for a limited purpose. In the event no such reaction occurs, FBI policy and federal law dictate that no further record is made of the protected activity.

During the course of this interview, the following significant information was identified:

[redacted] has been in the Chicago, Illinois area for approximately three weeks. He hitched hiked from Atlanta, Georgia to Rockford, Illinois and then made his way to Chicago.

[redacted] describes himself as a transient and homeless individual, not affiliated with any Anarchist type groups nor associating with individuals associated to the Anarchist movement. [redacted] is driven to travel and relocate from the "vibrations" he feels and "voices" he hears. [redacted] stated he is not currently taking any form of medication, but has taken medicine to treat schizophrenia.

[redacted] also stated his violent outburst at the "Occupy Chicago" protest was a result of his anxiousness and claustrophobia. [redacted] stated he is remorseful regarding his actions during the incident.

****Writer's note: Previous law enforcement reporting identified [redacted] acting out violently assaulting a law enforcement officer while a participant at an occupy Chicago protest.****

On 11/03/2011, Special Agent (SA) [redacted] and Intelligence Analyst [redacted] interviewed [redacted] date of birth: [redacted] at the Cook County Department of Corrections, 2700 South California Avenue, Chicago, Illinois. After being informed of the identities of the Federal Bureau of Investigation (FBI) employees and the nature of the interview, [redacted] (here-in-after [redacted]) provided the following information:

[redacted] has been in the Chicago, Illinois area for approximately three weeks. He hitched hiked from Atlanta, Georgia to Rockford, Illinois and then made his way to Chicago.

[redacted] was born and spent his first 10 years in Mississippi. He then moved to Richmond, Kentucky until approximately age 16. [redacted] relocated to New Orleans, Louisiana for approximately one year then moved back to Richmond, Kentucky where he flunked out of general education college courses at Eastern Kentucky college. [redacted] moved back to Atlanta, Georgia staying for approximately one year, then moved to Phoenix, Arizona for approximately one year. While in Phoenix, [redacted] made visits to San Francisco, California and Seattle, Washington. [redacted] then moved back to Richmond, Kentucky for approximately one year. Lastly [redacted] moved to Atlanta, Georgia where he stayed for approximately four years before making his way to Chicago, Illinois.

[redacted] is homeless and characterizes himself as a "bum, hobo" or transient. He primarily train hops or hitchhikes to travel and "dumpster dives" as a means to subsist and find food. [redacted] also receives social security benefits for approximately \$630.00 a month which he has sent to a designated "payee" located in the Atlanta, Georgia area. [redacted] designated payee then sends [redacted] \$150 a month via Western Union. [redacted] also receives medical benefits under Medicare plan A and B.

He is driven to travel and relocate from the "vibrations" he feels and "voices" he hears. [redacted] stated he is not currently taking any form of medication, but has taken medicine to treat schizophrenia. [redacted] also stated his violent outburst at the "Occupy Chicago" protest was a result of his anxiousness and

claustrophobia. [REDACTED] stated he is remorseful regarding his actions during the incident.

[REDACTED] has several tattoos visible on his arms. One tattoo on [REDACTED] which [REDACTED] explained symbolizes his faith. Another tattoo on [REDACTED] has the phrase [REDACTED] which [REDACTED] explained is a mantra he uses every time he feels desperate or suicidal. [REDACTED] explained he has attempted suicide in the past.

[REDACTED] was drawn to Chicago for no particular reason. He happened to be hitchhiking, wanted to travel up north and was able to find someone who gave him a ride to Rockford. [REDACTED] does not know anyone in the Chicago.

[REDACTED] chooses to maintain a transient lifestyle and believes money and greed leads to sin. When released, [REDACTED] is not sure if he will remain in Chicago or travel elsewhere. If he is mandated by the court to remain in Chicago, [REDACTED] will probably stay at shelters, missions and/or along [REDACTED] Drive where there is heat.

[REDACTED] was attracted to the "Occupy Chicago" rally because of the excitement and people playing musical instruments. [REDACTED] does not agree with anarchy stating it is a sin, does not belong to any anarchist groups or organizations and does not associate with individuals in the anarchist movement. [REDACTED] expressed his dissatisfaction with the increased level of poverty amongst the middle class, but stated he was taken care of by the government citing his social security and medicare benefits.

While at the rally, no one ever approached [REDACTED] to participate in any illegal activity related to anarchist extremism. No one ever attempted to recruit [REDACTED] into an anarchist group and [REDACTED] never was invited to attend any meetings relating to G-8/NATO. [REDACTED] classified most of the attendees at the "Occupy Chicago" rally as artificial and more present for show.
